
Overall Goal of "PANORAMED":

- ➤ to establish an innovative permanent dialogue and decision making process among national and regional public authorities and stakeholders to contribute to informed policy and decision making processes at national and transnational level on common challenges and opportunities in the Mediterranean Region.
- Specifically, the initiative will support the definition of transnational governance joint frameworks for the identification and implementation of shared approaches, policies and strategic projects.

Methodology



- With a total of 19 partners,
 PANORAMED is composed by
 Ministries and Regions coming from
 12 participating States of the MED
 Programme
- Woks as a platform of National and Regional authorities, through transnational Thematic Working Groups (TWG), involving strategic key actors,
- Identifies shared policy approaches and strategic top down projects.





Cross Cutting Liaising Thematic Tasks

Coastal and Maritime Tourism:

- Regional priority comparative advantage of coastal and insular MED regions.
- Very important in the tourist economy economic potential of the Regions.

Maritime surveillance:

- National priority of strategically planning and transnational cooperation
- Regions: a crucial stakeholder and end user at the sea.
- Of high importance for security plans and safe living, working, and leisure.





Liaising Objective

The objective of the cross cutting task liaising is:

to support synergies and dynamic with the other programmes/initiatives/strategies active in the Mediterranean to act cooperation and complementarities.

- Communication activities also must be necessarily linked to the cross cutting liaising task.
- Cross cutting task liaising is functional to the thematic WPs costal and maritime tourism and maritime surveillance.

Cross cutting Task Liaising will be developed into two branches:

- a) one related to the coordination/complementarities among *MED, ADRION, BALKAN MED, SOUTH WEST and ENI CBC MED* and
- b) one dedicated to the **coordination/complementarities/contribution to dynamics and strategies** active in the Mediterranean.


