

Reinforced maritime surveillance at the heart of the Mediterranean




- **5 Projets pour la promotion de la chaîne du Gaz Naturel Liquéfié (GNL)** → études de faisabilité, diffusion des connaissances, modèles de chaînes de transport GNL, tests et mise en place du réapprovisionnement GNL, stations pilotes
- **2 Projets pour prévenir l'enlisement des ports** → incorporation des processus de gestion durable des sédiments, expérimentation d'un système de prévision et de suivi de l'enlisement au sein de 3 ports (Piombino, Savone et Toulon)

State of play : results

Améliorer les connexions, réduire les distances

- Un **GEECT** pour la mise en place de **transports durables entre la Sardaigne, la Corse et l'Île d'Elbe** permettra d'augmenter la fréquence des transports dans la zone et d'affronter, de manière concrète et innovante, le sujet de la continuité territoriale transfrontalière.
- Une **route maritime** qui relie le nord-est de la **Sardaigne** et le sud-ouest de la **Corse** (Porto Torres/Propriano-Ajaccio (marchandises et passagers). La route est l'unique voie maritime qui relie les deux zones insulaires et qui garantie la liaison avec les couloirs de transports européens par le biais du prolongement de celle-ci sur Marseille.
- Un **plan de faisabilité** impliquant tous les 5 territoires pour augmenter **l'accessibilité aérienne** de la zone de coopération

GEECCTT-îles action-project has the objective of creating a GECT, i.e. an instrument for establishing ‘crossborder territorial continuity’ to establish inter-island connections that meet the needs of the territories of Corsica and Sardinia, and even Elba, which are poorly accessible.
