During the last two programming periods, the Cooperation Programmes that have affected the countries bordering the Mediterranean allowed the development of projects that highlight how the strategies of each Countries (national, regional and local public institutions) can be effectively implemented through partnerships able to develop synergies and complementarities to increase the added value of the CTE. In particular, the 2014-2020 ESI Funds programming period, and of the ETC in particular, has encouraged the development of a working method aimed at the building of a more qualified and easier path towards broader goals identified in the Union, for example, within the framework of the Europe2020 strategy, and to support actions to address the challenges posed by the new scenarios that have recently been outlined.

Alongside the Cooperation Programmes, a varied and qualified universe of international and supranational institutions and organizations has kept up the level of attention towards the main development trajectories involving different levels of government and having relationship, in many cases, with the European Commission to share common paths for strengthening the dynamics of territorial development, also going beyond geographical and political borders.

In order not to disperse this wealth of knowledge and to enhance the results achieved to date with a view to strengthening the Mediterranean vision of development policies, the Agency for territorial cohesion with the Department for Cohesion Policies, the Emilia-Romagna Region and ERVET, continuing the path launched during the European Cooperation Day, last 21 September 2017, promotes a day of debate at European level on the issue of basin and maritime cooperation. Representatives of the European Commission, EU member countries, pre-accession countries and international organizations will be invited to intervene. The aim is to collect suggestions and reflections on the topic, with particular attention to the obstacles and possible solutions to improve maritime cooperation in Europe.
